To facilitate a more efficient and effective resolution process, resolutions for consideration at a BCAFN Assembly should be received in advance of an Assembly, including a completed Resolution template and background information or supporting documentation if necessary.

This should allow sufficient time for resolutions to be typed, reviewed, edited, approved and copied prior to distribution at the Annual Chiefs' Meeting, which in turn should result in more time for review, consideration and discussion of resolutions on the floor. We look forward to your cooperation in implementing this request for advance submission of resolutions.

Late or Emergency Resolutions deadline is 12:00PM on September 22, 2022. Any resolutions submitted after this deadline will be considered at the upcoming BCAFN Special Chiefs Assembly, Spring 2023
