MESSAGE FROM REGIONALCHIEF TERRY TEEGEE



I extend my gratitude to participants for your interest in joining the BCAFN Housing Forum and with to thank Lheidli T'enneh for allowing us to host this important event on their territories. Over the next two days, we will discuss critical issues surrounding First Nations housing insecurity and homelessness, including housing on and off reserve, the impacts of the climate emergency and upholding the United Nations Declaration on the Rights of Indigenous Peoples (UN Declaration) at the municipal, provincial and federal levels. We will also provide space for First Nations to inform the mandate, scope and framework of the First Nations Housing and Infrastructure Council

During the forum, we will host various Chiefs, leaders and experts to discuss key issues, community-led solutions and recommendations on how to move forward at the community, regional, and national level. First Nations face complex and disproportionate challenges in addressing these issues due to historic and ongoing racism, perpetuated by systemic barriers, including inadequate funding. With the recent provincial and federal adoption of the UN Declaration, governments at all levels must work with First Nations to uphold our inherent right to sufficient, culturally appropriate, and climate-resilient housing.

Collaborative efforts are vital to developing policies and initiatives addressing immediate concerns and working towards sustainable, long-term solutions. By incorporating the voices and perspectives of First Nations rights holders in BC, we can develop strategies and advocate for policy and legislative changes that are rooted in upholding the UN Declaration.

I look forward to listening to the dialogue over the next two days and sharing a What We Heard report with participants over the next month to highlight the takeaways from these important discussions.



KEYNOTE SPEAKER: CHAIRPERSON KHELSILEM, SQUAMISH NATION

ADDRESSING HOUSING NEEDS: THE SQUAMISH NATION LESSONS ON MARKET & NON-MARKET HOUSING DEVELOPMENT



Khelsilem is a prominent Indigenous leader and current Chairperson of the Skwxwú7mesh Úxwumixw (Squamish Nation). First elected to Council in 2017, Chairperson Khelsilem was an official Spokesperson and active in leading work on various projects and initiatives including developing a not-for-profit housing society and the Seńákw development, the largest Indigenous housing development in Canadian history. Chairperson Khelsilem's lifelong work has focused on progressive social change, including climate justice, social democracy and gender equity. Chairperson Khelsilem is a fluent speaker of Skwxwú7mesh sníchim (language) and prior to serving the Skwxwú7mesh Úxwumixw (Squamish Nation), he founded a program at Simon Fraser University to help train a new generation of Skwxwú7mesh sníchim (language) speakers.

Dakota Ray is an actor/comedian/writer on the rise. She was born and raised in Meadow Lake, Saskatchewan, and is a member of English River First Nation. On the small screen, Dakota co-stars in the CTV comedy **SHELVED** (now available on Crave) about a handful of smart and quirky characters who work at and inhabit a small, local library. She also co-hosts the informative and entertaining APTN series **CRAZY LIKE A LYNX**, alongside Indigenous comedian Don Kelly. Additionally, you can see Dakota on this season's RUN THE BURBS on CBC, as well as on **ROAST BATTLE CANADA** on Crave.

Dakota is also an accomplished stand-up comedian. She has performed across Canada, the US and Mexico. She has performed at the first Arctic Comedy Festival in Iqaluit and the first Drew McLean Comedy Festival in Kamloops, the Winnipeg Comedy Festival, and sold out her headlining run at Just For Laughs Toronto. Dakota can be seen on JFL/CBC's television show **COMEDY NIGHT WITH RICK MERCER**. Her first comedy album, "I'll Give You An Indian Act" is out and available for purchase, and can be streamed on all platforms. She is currently working on her second album **TRAILER TREASURE**, which she toured west this winter; she's working on an eastern tour. Dakota also just wrapped her performance at **JUST FOR LAUGHS MONTREAL** as part of New Faces: Canada.

Always in demand, Dakota has several television shows in development, writing, co-writing and consulting on. The contracts she can talk about are CTV's **SHELVED** and CBC's **ZARQA**. In theatres, Dakota stars in the fantastic feature film, **RUN WOMAN RUN**, produced by Big Soul Productions, and written and directed by Zoe Hopkins. Her outstanding performance won her the Best Actress Award at the 2021 American Indian Film Festival. It opened wide in theatres March 2022 and is currently streaming on Crave and CBC Gem. HOUSING INSECURITY AND THE CLIMATE CRISIS PANEL Moderated by Kyle Alec

Over the past five years, First Nations communities in BC have endured unprecedented climate emergencies, including fires, floods, and drought. The purpose of this discussion is to share experiences and explore innovative solutions to inform policy, inspire collaborative strategies, and develop a collective roadmap for addressing these pressing issues in a holistic and sustainable manner. The panel will be opened by former Chief Patrick Michell, who will share his personal experience in the wake of the fires that decimated his home and parts of his community in 2021.

Patrick Michell, Kanaka Bar Indian Band

Patrick Michell is a Retired Chief of Kanaka Bar Indian Band and resident of Lytton, BC. Patrick has an Administrative Management diploma from Douglas College, and a Bachelor of Law. After working in Vancouver with DFO and INAC, Patrick articled with the Ministry of Attorney General, and Richards Buell Sutton, before being called to the Bar in 1997.



Chief Arnold Lampreau, Shackan Indian Band

Hello, my name is Arnie Lampreau (Swakum). My mother is the late Sara F. Swakum and she was living with Stanley Joe in the late 60's and that is how I came to be residing in Shackan, or 14 Mile Ranch. I have a sister, Connie Swakum and a brother Greg Joe. Boby Joe and Joan Saddleman are also siblings of mine from Stanley Joe.



Andrea Reimer, Adjunct Professor, UBC

Former three-term Vancouver Councillor & Metro Vancouver Director, one-time school trustee and former National Green Municipal Fund Council member. Awarded a Loeb Fellowship at Harvard's Graduate School of Design in recognition of urban policy achievements. Currently teaching about how power works in practice at UBC and SFU and consulting with local governments, First Nations, non-profits and mission driven local businesses prepared to act with courage on bold policy. For the past several years, the First Nations Housing and Infrastructure Council (FNHIC) has been embarking on a lengthy engagement process with the First Nations across British Columbia. Through this process, First Nations have echoed the need for a BC-based Housing Managers Association.

The BC First Nations Housing Managers Association seeks to provide mentorship, professional development opportunities, and access to funding and operational resources to support a successful, healthy community while appreciating the cultural diversity of communities throughout the province.

FNHIC is excited to offer this association free of charge to all housing workers in First Nations across British Columbia. This dialogue session explores the association's roots, how it will run and what it will offer. Time permitting there will be questions and discussion following the presentation.

Dialogue Session hosted by Lory Oberst, FNHIC

Lori comes from a strong background of administration and management and holds a First Nations Housing Manager Certificate from Vancouver Island University and is a Certified Aboriginal Professional Administrator through the AFOA. Prior to joining FNHIC-BC she worked with for Skwah First Nation for over nine years, starting as the Housing Manager and gradually taking on more duties until becoming the Director of Operations in 2018. ROUNDTABLE DIALOGUE ON CLOSING THE INFRASTRUCTURE GAP WITH FEDERAL AND PROVINCIAL PARTNERS

Moderated by Michael Sadler, FNHIC

Housing funding is complex and multi-jurisdictional. This session will provide funders with an opportunity to engage with and share Indigenous-specific funding programs with participants. This panel will begin with a presentation by **Matthew George, Policy Analyst at the Assembly of First Nations, who will provide a summary of the AFN's Closing the Infrastructure Gap by 2030 report,** followed by presentations from federal and provincial partners and a Q&A for participants to provide feedback on the following questions:

- 1) What can government agencies and funders do to support administrative challenges or gaps? (e.g., clarity over funding criteria, consistent template submissions, reporting timelines, templates, reporting criteria, etc.)
- 2) Are you aware of untapped capacity in your communities that funders and government agencies can support/nurture? (e.g., cross-training, skills-sharing/development, job-shadowing etc.)
- 3) Many First Nations have called for a transfer of services and program delivery for housing away from government agencies and, instead, have First Nations assume control of their own housing and infrastructure service and program delivery. Many First Nations in BC support a coordinated First Nations-led housing authority, such as the work undertaken by the First Nations Housing and Infrastructure Council. Others seek to take this on at the community level. What does a transfer of authority look like in your community, and how can government agencies and First Nations organizations work to support this?

Mary is a values-driven professional who has dedicated her career to the pursuit of work that supports social and economic inclusion of marginalized communities. Mary is Indigenous to Egypt as a member of the Coptic community who traces their ancestry back to the pre-Arab ancient Egyptian peoples. Mary's passion for working in the reconciliation space stems from her experience working on multiple reconciliation files, including the Indian Residential Schools Settlement Agreement, and with Indigenous non-profits such as Reconciliation Canada and Indigenous Tourism BC. She's currently a board member of the Orange Shirt Society.



Jessica Gordon, Senior Director for the Housing and Infrastructure Service Reform Directorate at Indigenous Services

Her current work supports the transfer of care, control and management of housing and infrastructure to First Nations in the spirit of self-determination. Jessica holds a degree in Political Science from the University of Ottawa, and has served most of her public service career in various sectors within Crown Indigenous Relations and Northern Affairs Canada (CIRNAC) and Indigenous Services Canada (ISC). Jessica has supported corporate roles within the departments as well as external facing roles engaging with communities.



Deanna Bhandar, Specialist, Indigenous and Northern Housing Solutions, CMHC

Deanna joined the INHS BC team with CMHC as a Specialist working with First Nations and urban Indigenous housing providers in 2021. Prior to joining CMHC, she worked as the Director of Real Estate Development for a large scale non-profit in Victoria leading the delivery of over 220 units. Her work in the affordable housing sector began over 20 years ago and has included tenures with both the federal, provincial governments, and financial institutions with a focus on delivering a wide range of housing solutions including homes for people experiencing homelessness to seniors housing and affordable rental.

The First Nations Housing & Infrastructure Council (FNHIC) is creating a First Nations-led Housing and Infrastructure Organization in British Columbia for First Nations 'based on First Nations' traditional values, principles, and governance practices. It's imperative that FNHIC establishes a system of governance that meets the needs of the organization as well as those people it serves including Chiefs, leadership and community members. This engagement session focuses on what these systems could look like and how those accountability mechanisms will work to serve the interests of First Nations in BC.

Presenters

Maia McKinley, Office of the Federal Housing Advocate

Maia McKinley (she/her) lives on the unceded territories of the lekweŋen-speaking people, including the Songhees and Esquimalt First Nations. She is a Senior Policy Advisor with the Office of the Federal Housing Advocate and supports the Advocate's duties to engage with people experiencing homelessness and housing precarity, conduct research, and monitor and review systemic housing issues in Canada. Maia is a collaborator by nature with years of community-based engagement and intergovernmental relations experience. She draws from her roots in the non-profit sector and her experience in housing and immigration policy at the provincial and federal levels to passionately advocate for human rights-based solutions and Indigenous reconciliation. She is a proud mother of four children (two with fur and two without) and seeks time in nature every day.



Dr. Joe Hermer, University of Toronto

Joe Hermer is an Associate Professor at the University of Toronto, and Chair of the Sociology Department at the University of Toronto Scarborough. He works in the area of law and criminology with a particular focus on the policing and regulation of vulnerable populations. He is currently the lead investigator of the Policing and Homelessness Initiative (policinghomelessness.ca). One of the main projects of this initiative is the mapping of anti-homeless offences located in municipal by-laws across Canada, including a report written with the BCAFN entitled "Move On: The First Ninety-Nine Days of the City of Prince George Safe Streets Bylaw".

MINISTERIAL UPDATES PROVIDED BY THE MINISTER FOLLOWED BY A SHORT Q&A



Ravi Kahlon was first elected as MLA for Delta North in May 2017. He is B.C.'s Minister of Housing. He previously served as the Minister of Jobs, Economic Recovery and Innovation, and before that held several Parliamentary Secretary roles.

As Parliamentary Secretary for Forests, Lands, Natural Resource Operations and Rural Development, he championed the use of mass timber and innovation in B.C.'s forest sector. As Parliamentary Secretary for Sport and Multiculturalism he helped restore the BC Human Rights Commission and traveled the province to build an anti-racism strategy.

As Minister of Jobs, Economic Recovery and Innovation, Ravi's first priority was to support families and communities through the pandemic and he worked closely with businesses, workers, First Nations and communities to develop and deliver on a strategy for long-term sustainability, jobs and growth.

Ravi's love for sports and athletic competition has also shaped his outlook. When he was seven years old, his father introduced him to field hockey. A two-time Olympian, Ravi played field hockey for Team Canada at the 2000 and 2008 Olympics.

Katisha Paul, UBCIC Youth Representative

Katisha Paul, also known as Kwikws <u>lvs</u>áos (Little Angel), is a xwílŋəxw słéni? (woman of this land: She/her pronouns) from the W JOŁEŁP and Lil'wat nations. She was recently elected as the Union of BC Indian Chiefs (UBCIC) Youth Representative and is an administrative mentee of Tsatsu Stalqayu (Coastal Wolf Pack). Kwikws <u>lvs</u>áos advocates for the advancement of land, title, and human rights by implementing the action items of the Declaration Act Action Plan, amalgamating Indigenous law and Canadian law, and sustaining Indigenous relations.



Matthew Norris, President of Urban Native Youth Association

Matthew is the president of the Urban Native Youth Association, which provides programming for Indigenous youth and their families. Norris brings years of policy experience with the BC Assembly of First Nations, Union of BC Indian Chiefs, the Canadian Centre for Policy Alternatives, and as an Indigenous delegate to the United Nations. He is Nehithaw and a proud member of Lac La Ronge First Nation.



The Daylu Dena Council recently completed a housing project on reserve in partnership with the Province of BC and BC housing that seeks to provide housing for women, children, youth and people experiencing or at risk of homelessness in Lower Post, managed by the Lower Power First Nation Housing Society. A Youth from Lower Post will be sharing about the impacts of the project on youth in the community.

FIRST NATIONS HOUSING AND INFRASTRUCTURE COUNCIL TIER 1 ENGAGEMENT (FIRST NATIONS-ONLY) - TRANSFER OF AUTHORITY

FNHIC cannot proceed with a transfer of authorities from Indigenous Services Canada without getting an endorsement from BC First Nations Leadership as they represent the First Nations rights and title holders in BC and also have the responsibility working with their respective communities to make important decisions that will ultimately have an effect on their lives. 53 First Nations have signed Band Council Resolutions to support FNHIC's transfer. This session will share more about what a transfer of authority would look like and provide space for participants to share their perspective on the transfer process.

Kerry Black - Senior Advisor

Kerry brings research experience and expertise relating to sustainable infrastructure in First Nations communities to her work with HIC. She has worked for the past 10 years in both the public and private sectors, on water and wastewater management in First Nations communities across Canada. Most recently Kerry served as a Senior Policy Advisor in Housing & Infrastructure with the Assembly of First Nations. Kerry previously worked as an Assistant Professor at the University of British Columbia in Civil Engineering. She has just transitioned to the University of Calgary as a Schulich Research Chair, and maintains a strong base in BC. Her work is centered on community-based participatory approaches, encompassing research relating to engineering infrastructure and sustainable communities, with a key focus on the incorporation of Indigenous-centered research methodologies.

Patrick Michell is a Retired Chief of Kanaka Bar Indian Band and resident of Lytton, BC. Patrick has an Administrative Management diploma from Douglas College, and a Bachelor of Law. After working in Vancouver with DFO and INAC, Patrick articled with the Ministry of Attorney General, and Richards Buell Sutton, before being called to the Bar in 1997.



Leona Humchitt, Climate Action Coordinator at Haiłzaqv Nation

Zuxvalaqs (Leona Humchitt) was raised to serve her community, and being a grandmother now drives her passion for this work. She attended COP26 in Glasgow as a member of the Indigenous Clean Energy Advisory Board. Leona is working locally and regionally with a peer network of Climate Action Coordinators who represent eight participating Coastal First Nations of B.C. They support each other and collaborate on efforts to decarbonize our coast in order to transition from diesel generation and reduce the transportation of fossil fuels through their ecologically and culturally significant territories.



Nicola Prokrop , Leader, Indigenous Reconciliation & Partnerships, Technical Safety BC

Nicola is a passionate and dedicated Anishinaabe professional with 8+ years of experience in public policy and change-making through a decolonial lens. She began her career working with urban Indigenous organizations to advocate for the importance of Indigenous-led mental health and addiction services, and she brings this commitment to Indigenous well-being to her work at Technical Safety BC. Nicola specializes in strategic planning and implementation, project management, multi-sectoral stakeholder relationship building, and community engagement.

ADDRESS BY MARIE-JOSÉE HOULE. - FEDERAL HOUSING ADVOCATE

UNITED NATIONS DECLARATION ON THE RIGHTS OF INDIGENOUS PEOPLES ACT AND THE HUMAN RIGHT TO ADEQUATE HOUSING

Marie-Josée Houle was appointed as Canada's first Federal Housing Advocate in February 2022, marking a new chapter in a career defined by her work in the affordable housing and homelessness sector.

Ms. Houle is an experienced leader who is recognized for her community activism, expertise in human rights, and extensive knowledge of the housing and homelessness system.



Prior to her appointment as Canada's first Federal Housing Advocate, Ms. Houle has held a number of roles that inform her broad experience, including frontline work in housing co-ops, consulting and project management for affordable housing development, by-law review, housing-related research projects, developing educational programs for housing co-ops and non-profits, and senior leadership roles.

Ms. Houle has been actively involved in advocacy work at a national, provincial and community level. She has advocated for tenant rights and the non-profit housing sector at all three levels of government. She has worked with diverse partners in the sector to foster innovation and entrepreneurship, improve efficiencies, influence key opinion leaders, leverage strategic partnerships, and address gaps and human rights violations related to housing and access to housing. Building a sense of community among diverse partners is particularly important to her. Ms. Houle has been a member the National Right to Housing Network, the Ottawa Alliance to End Homelessness and the Canadian Housing Renewal Association. She sat on the Ottawa Homelessness Community Advisory Board, the Ottawa Social Housing Network Steering Committee, and co-chaired both the City of Ottawa's Housing Loss Prevention Committee, and the Refugee 613 Housing Task Force.

Priscilla Mueller is the elected Chief of Saik'uz First Nation and a member of the Grouse Clan. She is married to Reg Mueller and has three children and two grandchildren.



Chief Dan Manuel, Upper Nicola Band

Dan Manuel was elected Chief of the Upper Nicola Band in 2023 and currently sits on the Assembly of First Nations Chiefs Committee on Housing and Infrastructure as the Chief representative of BC.



BCAFN Regional Chief Terry Teegee

Terry Teegee, is proudly serving his third term as the elected Regional Chief of the British Columbia Assembly of First Nations. Terry's ancestry is Dakelh, Gitxsan and Sekani descent and is a member of Takla Nation. As Regional Chief, he has been an instrumental voice in the development and historic passing of the Declaration on the Rights of Indigenous Peoples Act.



Fran Hunt-Jinnouchi - Executive Director, Aboriginal Coalition to End Homelessness

Fran has more than 20 years of experience in senior management and direct engagement working with Indigenous peoples. Her areas of expertise include Indigenous adult and post-secondary education and training. Fran is currently the Executive Director of the Aboriginal Coalition to end Homelessness and was the inaugural Director of the Office of Indigenous Affairs at the University of Victoria.

Seed funding

The Seed Funding program supports affordable housing through interest-free loans and/or non-repayable contributions. There are two funding streams: one for new construction/conversions and one to preserve existing community housing projects. For more information and to apply click here

National Housing Co-Investment Fund

The National Housing Co-Investment Fund provides capital to First Nations and non-profit housing providers for new affordable housing and renovating and repairing existing affordable and community housing. Canada Greener Affordable Housing

Canada Greener Affordable Housing helps affordable housing providers complete deep energy retrofits on existing multi-unit residential buildings. Pre-Retrofit funding supports costs for completing the pre-retrofit activities needed to plan, prepare, and apply for CGAH Retrofit Funding.Retrofit Funding will address climate capability and resiliency to multi-unit (5+) residential buildings, by providing forgivable loans and low-interest loans to help finance building retrofit measures and activities needed to meet climate objectives, leading to deep reductions in energy consumption and GHG emissions. Housing Support Program (HSP)

HSP provides First Nations with funding through a subsidy based program that support the following activities:

- 1.Governance & Capacity: Housing policy and plan development, and non-post-secondary or certification related training.
- 2. Housing Projects: new construction, renovations, energy efficiency and multi-plexes.

Funding Deadline: HSP new construction, renovations and energy efficiency activities, are through a continuous intake. HSP multi-plex FY 2024-2025 deadline is Wednesday, November 15, 2023.

ISC Headquarters

ISC's On-Reserve Housing Team (headquarters) has developed national parameters to support the release of Budget 2022 funds to address housing gaps and capacity enhancement activities.

Authorities derive from the overall Capital Facilities and Maintenance Program which guides communities infrastructure in First Nations communities. Applicants with projects of national scale are eligible to apply through headquarters, where others with regional specific activities must liaise directly with their respective regional office.

Eligible funds include:

- Capacity and Innovation: investments for national projects and initiatives that support First Nations' self-determination and self-governance (in mid to long term), support the implementation of national or regional First Nations housing strategies, and reduce reliance on federal funds. Funding can be used for testing, scale up and full roll out of proposed innovative approaches and skills and capacity enhancement projects.
- Construction and Immediate Needs: addressing immediate housing needs. The Immediate Needs Fund can provide funding for construction, renovations, additions and lot servicing for First Nation communities located on reserve, or on land set aside in Yukon territory.
- Subdivisions: intended to for development of new subdivisions and to address key infrastructure needs of new and existing subdivisions, such as lot servicing, road infrastructure, connections to drinking and waste water and electrical to existing networks.
- Housing Management Subsidy: supports First Nation communities who wish to increase their capacity around housing governance, management, training, planning and finance.

Deadlines: Applications are reviewed on an ongoing basis. Review of applications for fiscal year 2024-25 is permissible.

BC Housing

Community Housing Fund (CHF)

Submission Deadline is November 17, 2023.

The Province of British Columbia created the <u>Community Housing Fund (CHF)</u> in 2018. This fund is a \$3.3-billion investment to build more than 20,000 affordable rental homes for people with moderate and low incomes by 2031-32. Approximately 9,000 of these homes are open or underway across the province. The CHF has received funds for an extra 6,000 new homes for families and seniors. Over the next four years, the plan is to issue more CHF proposal calls and allocate the remaining units.

Community Housing Fund RFP Factsheet

Indigenous Housing Fund (IHF)

The Province, through the Building BC: Indigenous Housing Fund, is investing \$550 million over 10 years to support the building and operation of 1,750 new units of social housing for projects on and off-reserve. Together, with our non-profit housing providers, the Aboriginal Housing Management Association, Indigenous housing societies and First Nations, we're working hard to make housing better in all communities. In addition, Indigenous organizations and First Nations can access provincial support under all the new housing funds announced as part of Building BC.

The program is aimed at Indigenous families, seniors, individuals, and persons with a disability.
